- 5. The council of The Corporation of the Township of La Vallee supports the submission of a Proposal for the Long-Term Energy Project located on the Municipal Project Lands.
- 6. This resolution's sole purpose is to satisfy the mandatory requirements of Section 4.2(c)(iii) of the LT2(e-1) RFP and may not be used for the purpose of any other form of approval in relation to the Proposal or Long-Term Energy Project or for any other purpose.
- 7. The Proponent has undertaken, or has committed to undertake, Indigenous and community engagement activities in respect of the Long-Term Energy Project to the satisfaction of the Municipality.
- 8. The Municipal Project Lands does not include lands designated as Prime Agricultural Areas in The Corporation of the Township of La Vallee's Official plan. CARRIED
- 434. <u>HYATT/LOSHAW:</u> BE IT RESOLVED that the Township of La Vallee hereby approves the Administrative Assistant to register for the Municipal Administration Program -Unit 3 and the Municipal Administration Finance Program -Unit 2 and that all registration costs in the amount of \$1,152.60 be paid.
